### NOTICE OF PUBLIC HEARINGS

#### **Text Amendments Regarding Secondary Suites and Detached Accessory Dwelling Unit Regulations**

The Cariboo Regional District (CRD) proposes to amend its rezoning and rural land use bylaws No. 3500 to 3505, covering the CRD in its entirety, by adopting amending bylaws No. 4988 to 4993. These text amendments propose new definitions, and changes to regulations to introduce secondary suites and detached accessory dwellings as permitted residential land uses.
